 - 2. Total delinquent is \$77,008; made up of 24 liens, 17 association foreclosures, 9 bankruptcies, 10 mortgage foreclosures. Total of 8% delinquency.
 - 3. Month to date under budget by \$5526
 - 4. Account number 0S17-0000-0767-01 requested the NSF fee of \$35 be removed from his account thinking Pay Lease had made a mistake, when it was he that made the mistake. Maria motioned to not waive the \$35 fee, Shaun 2nd and all were in favor.
 - b. Violations; currently there are 389 open violations and all can be reviewed on Connect. There was a complaint about a home on Dragon Head. It has storm shutters up, an artificial snake wound through the fence and numerous cameras. Home was inspected and found this to be true. Investor owner was contacted regarding the home.
